THE STORE SELLS NEW AND USED BUILDING COMPONENTS, HARDWARE, FURNITURE AND HOUSEHOLD GOODS AT 50% TO 75% OFF RETAIL PRICE TO THE LOCAL COMMUNITY. VOLUNTEERS AND COMMUNITY SERVICE WORKERS MAKE UP THE BULK OF THE SUPPORT STAFF IN THIS PROGRAM. DUE TO RESTORE SALES AND RECYCLING PROGRAMS, TONS OF REUSABLE MATERIALS ARE KEPT OUT OF THE LANDFILL ANNUALLY.
